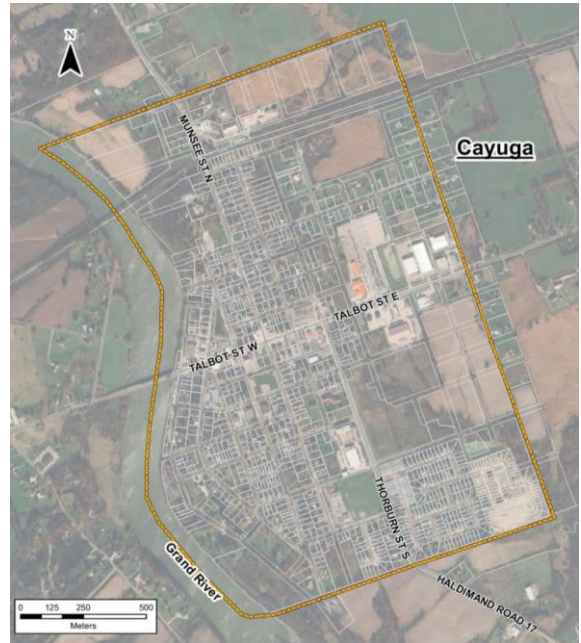
## Cayuga Master Servicing Plan Update

*Haldimand County has initiated a Municipal Class Environmental Assessment (MCEA) to update the Master Servicing Plan (MSP) prepared in 2010 for the community of Cayuga.*

### PROJECT BACKGROUND

The purpose of this study is to update the four (4) servicing components of the previous Cayuga MSP to reflect updated land use and growth forecasts in the study area. The updated MSP will guide future infrastructure projects in the community.

As part of Phase 2 of this MSP, the County is developing a set of water, wastewater, stormwater, and transportation infrastructure improvements required for future servicing needs, as well as proposed phasing for the implementation of these infrastructure servicing projects. The proposed infrastructure alternatives may have an impact on stakeholders, rightsholders, and residents, therefore, consultation continues to be a key element of the process. Existing conditions (Phase 1) were previously presented during Public Open House No. 1.
