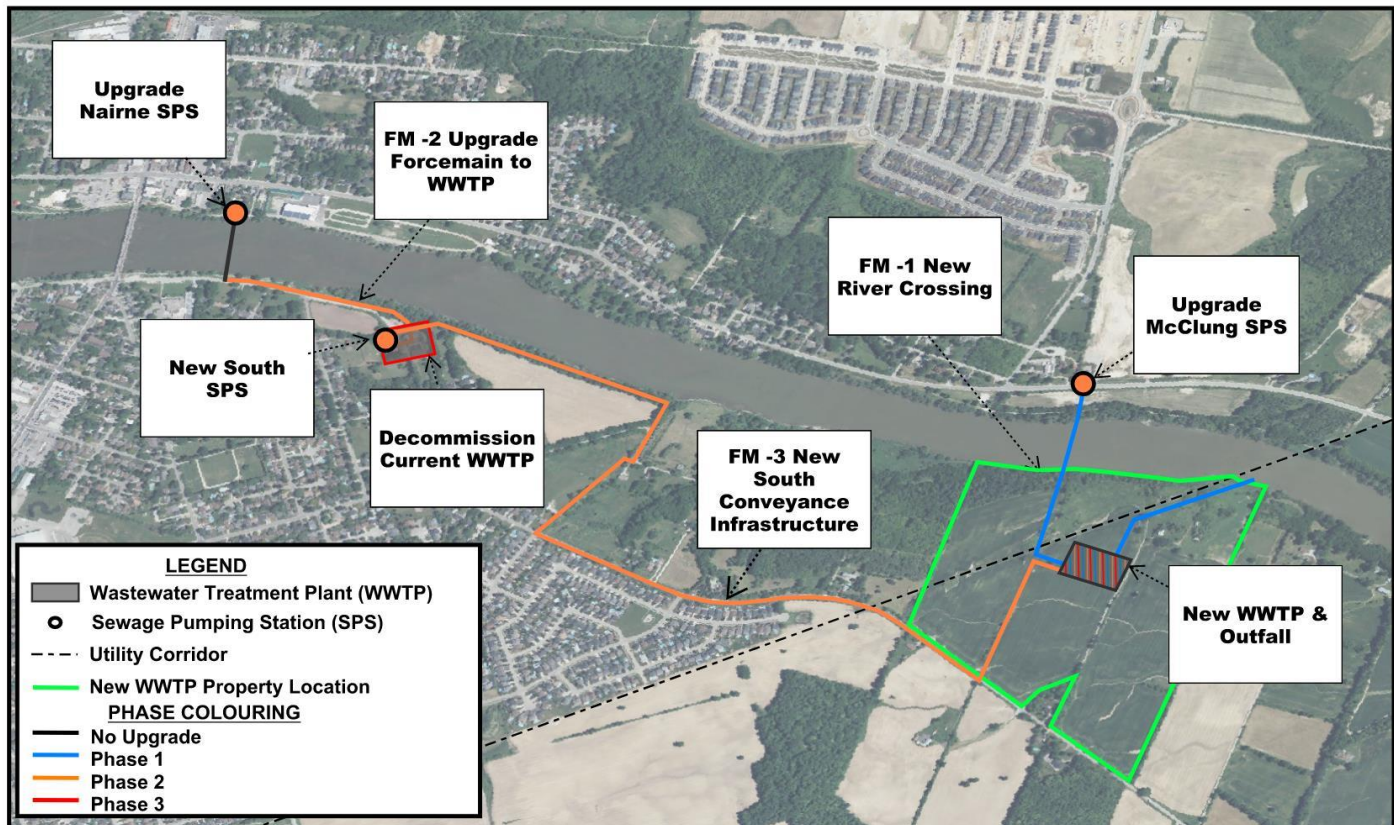


# Notice of Completion

## Haldimand County Schedule 'C' Municipal Class Environmental Assessment Caledonia Wastewater Treatment Plant

Haldimand County (the County) has completed a Schedule 'C' Municipal Class Environmental Assessment (EA) to identify the preferred alternative for increasing wastewater treatment capacity for the community of Caledonia. The Class EA assessed various options to ensure the preferred solution can service existing and future development within Caledonia.

The study included input from Indigenous and technical stakeholders and the public. The preferred servicing solution is a phased approach intended to match growth and maintain operation of the existing WWTP until it reaches the end of its useful life. Phase 1 consists of a new wastewater treatment plant (WWTP) and outfall located at 4300 River Road, as well as new conveyance infrastructure crossing the Grand River to redirect flows from the McClung sewage pump station (SPS) to the new WWTP. Subsequent phases include upgrades to the McClung and Nairne SPSs, construction of a new south SPS, decommissioning the existing WWTP, and ultimately directing all sanitary flows to the new WWTP through new and upgraded conveyance infrastructure.



**\*Note that the exact location of the New Wastewater Treatment Plant on the property, as well as the location of the outfall are conceptual in nature. The exact location will be confirmed during detailed design.**

This study is being conducted according to the requirements of a Schedule 'C' Class Environmental Assessment under the Ontario Municipal Class Environmental Assessment process (October 2000, as amended in 2015, 2023, and 2024).

In addition, a request to the Minister of the Environment, Conservation and Parks for an order imposing additional conditions or requiring an individual environmental assessment be made on the grounds that the requested order may prevent, mitigate, or remedy adverse impacts on constitutionally protected Aboriginal and treaty rights.
