


THE CORPORATION OF HALDIMAND COUNTY

By-law No. 735 

Being a by-law to prescribe the maximum rates of speed for portions of certain highways in Haldimand County. 


WHEREAS subsection 210.(123) of the Municipal Act, R.S.O. 1990, c.M.45, as amended, provides that subject to the Highway Traffic Act a local municipality may pass by-laws regulating traffic on highways 

WHEREAS section 128 of the Highway Traffic Act, R.S.O. 1990, c.H.8, as amended, provides that the council of the municipality may by by-law prescribe maximum rates of speed for motor vehicles driven on a highway or portion of a highway under its jurisdiction, upon which no person shall drive a motor vehicle at a rate of speed greater than;


WHEREAS paragraph 7 of subsection 314.(1) of the said Municipal Act confers upon the councils of all municipalities the power to pass by-laws to provide for the placing, regulating and maintaining upon the public highways traffic signs for the purpose of guiding and directing traffic;


AND WHEREAS the Council of the Corporation of Haldimand County deems it expedient to establish the maximum rates of speed for portions of certain highways under its jurisdiction;

NOW THEREFORE, the Council of the Corporation of Haldimand County enacts as follows:

1. **THAT** no person shall drive a motor vehicle on any portion of any highway under the jurisdiction of Haldimand County as identified in Schedule 'A', attached hereto and forming part of this by-law, at a rate of speed exceeding the corresponding maximum rate of speed for motor vehicles identified in the said schedule for that portion of highway 
2. **THAT** the General Manager of Physical Services of Haldimand County or his/her designate is hereby authorized to place or erect and maintain such official signs or traffic control devices or signals as are required to give effect to the provisions of this by-law or as required to warn or guide traffic for the safety or convenience of the public.
3. **THAT** every person contravening any provision of this by-law is guilty of an offense and upon conviction is subject to a fine recoverable under the Provincial Offences Act, R.S.O. 1990, c.P.33, as amended.
4. **THAT** any by-law or provision of any by-law of the Corporation of Haldimand County inconsistent with this by-law is hereby repealed.

5. **THAT** where a form of words or expression are prescribed in this by-law, deviations there from not affecting the substance or calculated to mislead do not vitiate them.
6. **AND THAT** this by-law shall come into force and take effect on the date of passing.

READ a first and second time this 8th  of August, 2006.

READ a third time and finally passed this 8th  of August, 2006.
