

THE CORPORATION OF HALDIMAND COUNTY

By-law No. 1450/14

Being a by-law to prescribe the maximum rates of speed for portions of certain highways in Haldimand County – Springvale

WHEREAS subsection 11 (1) of the *Municipal Act*, 2001, S.O., 2001, c. 25, as amended, provides that a single tier municipality may pass by-laws respecting traffic on highways under its jurisdiction;

WHEREAS section 128 (2) of the *Highway Traffic Act*, R.S.O. 1990, c.H.8, as amended, provides that the council of a municipality may by by-law prescribe maximum rates of speed for motor vehicles driven on a highway or portion of a highway under its jurisdiction;

AND WHEREAS the Council of the Corporation of Haldimand County deems it expedient to establish the maximum rates of speed for portions of certain highways under its jurisdiction;

NOW THEREFORE, the Council of the Corporation of Haldimand County enacts as follows:

1. **THAT** no person shall drive a motor vehicle on any portion of any highway under the jurisdiction of Haldimand County as identified in Schedule 'A', attached hereto and forming part of this by-law, at a rate of speed exceeding the corresponding maximum rate of speed for motor vehicles identified in the said schedule for that portion of highway;
2. **THAT** the General Manager of Public Works of Haldimand County or his/her designate is hereby authorized to place or erect and maintain such official signs or traffic control devices or signals as are required to give effect to the provisions of this by-law or as required to warn or guide traffic for the safety or convenience of the public;
3. **THAT** every person contravening any provision of this by-law is guilty of an offense and upon conviction is subject to a fine recoverable under the *Provincial Offences Act*, R.S.O. 1990, c.P.33, as amended;
4. **THAT** any by-law or provision of any by-law of the Corporation of Haldimand County inconsistent with this by-law is hereby repealed;

5. **AND THAT** this by-law shall come into force and take effect on the date of passing.

READ a third time and finally passed this 9thday of June, 2014.

**Maximum Rates of Speed for Motor Vehicles on Certain Highways
in Haldimand County**

| Highway | From | To | Maximum Rate of Speed |
|-----------------------|----------------------------|-----------------------------|----------------------------------|
| Haldimand Road 55 | Concession 14 Walpole | A point 375 meters north | 50 km/hr |
| Haldimand Road 55 | Concession 14 Walpole | A point 690 meters south | 50 km/hr |
| Concession 14 Walpole | Haldimand Road 55 | A point 770 meters east | 50 km/hr |
| Concession 14 Walpole | Haldimand Road 55 | A point 675 meters west | 50 km/hr |
| Concession 14 Walpole | A point 770 meters east | Haldimand Road 20 | 60 km/hr |
