

THE CORPORATION OF HALDIMAND COUNTY

By-law Number 1868/17

Being a by-law to levy the actual cost of maintenance of the Sweets Corners, King Branch 1 & 2, Sixth Concession, Weikman, Lundy, North Forks, South Forks, Maple Creek, Pat Warren, Jarvis 1 and County Road 3 Municipal Drains on the assessed lands

WHEREAS Section 61 of the *Drainage Act*, R.S.O. 1990, c.D17 provides that the council of the local municipality that is required to raise the cost of drainage works shall by by-law impose the costs upon the assessed land, payable in such installments as the council may prescribe;

WHEREAS Section 74 of the *Drainage Act*, R.S.O. 1990, c.D17 requires that the local municipality raise the cost of maintenance of drainage work at the expense of all upstream lands and roads in any way assessed for the construction or improvement of the drainage works;

WHEREAS the Sweets Corners Municipal Drain was maintained by Haldimand County at a total project cost of \$11,534.42 and now requires the remaining costs, after any applicable grants/allowances, of \$9,393.18 to be recovered from the lands benefiting from said work;

WHEREAS the King Branch 1 & 2 Municipal Drain was maintained by Haldimand County at a total project cost of \$26,737.05 and now requires the remaining costs, after any applicable grants/allowances, of \$21,364.82 to be recovered from the lands benefiting from said work;

WHEREAS the Sixth Concession Municipal Drain was maintained by Haldimand County at a total project cost of \$48,071.43 and now requires the remaining costs, after any applicable grants/allowances, of \$35,699.07 to be recovered from the lands benefiting from said work;

WHEREAS the Weikman Municipal Drain was maintained by Haldimand County at a total project cost of \$9,291.20 and now requires the remaining costs, after any applicable grants/allowances, of \$7,470.52 to be recovered from the lands benefiting from said work;

WHEREAS the Lundy Station Municipal Drain was maintained by Haldimand County at a total project cost of \$31,401.58 and now requires the remaining costs, after any applicable grants/allowances, of \$28,308.34 to be recovered from the lands benefiting from said work;

WHEREAS the North Forks Municipal Drain was maintained by Haldimand County at a total project cost of \$63,799.72 and now requires the remaining costs, after any applicable grants/allowances, of \$51,817.08 to be recovered from the lands benefiting from said work;

WHEREAS the South Forks Municipal Drain was maintained by Haldimand County at a total project cost of \$69,001.46 and now requires the remaining costs, after any applicable grants/allowances, of \$50,243.16 to be recovered from the lands benefiting from said work;

WHEREAS the Maple Creek Municipal Drain was maintained by Haldimand County at a total project cost of \$49,267.37 and now requires the remaining costs, after any applicable grants/allowances, of \$41,471.47 to be recovered from the lands benefiting from said work;

WHEREAS the Pat Warren Municipal Drain was maintained by Haldimand County at a total project cost of \$5,869.01 and now requires the remaining costs, after any applicable grants/allowances, of \$4,391.17 to be recovered from the lands benefiting from said work;

WHEREAS the Jarvis 1 Municipal Drain was maintained by Haldimand County at a total project cost of \$84,980.82 and now requires the remaining costs, after any applicable grants/allowances, of \$71,925.78 to be recovered from the lands benefiting from said work;

AND WHEREAS the County Road 3 Municipal Drain was maintained by Haldimand County at a total project cost of \$209.91 and now requires the remaining costs, after any applicable grants/allowances, of \$143.98 to be recovered from the lands benefiting from said work;

NOW THEREFORE, the Council of The Corporation of Haldimand County enacts as follows:

1. **THAT** The Treasurer shall levy the amount of \$9,393.18 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "A", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Sweets Corners Drain.
2. **THAT** The Treasurer shall levy the amount of \$21,364.82 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "B", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the King Branch 1 & 2 Drain.
3. **THAT** The Treasurer shall levy the amount of \$35,699.07 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "C", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Sixth Concession Drain.
4. **THAT** The Treasurer shall levy the amount of \$7,470.52 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "D", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Weikman Drain.
5. **THAT** The Treasurer shall levy the amount of \$28,308.34 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "E", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Lundy Drain.

6. **THAT** The Treasurer shall levy the amount of \$51,817.08 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "F", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the North Forks Drain.
7. **THAT** The Treasurer shall levy the amount of \$50,243.16 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "G", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the South Forks Drain.
8. **THAT** The Treasurer shall levy the amount of \$41,471.47 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "H", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Maple Creek Drain
9. **THAT** The Treasurer shall levy the amount of \$4,391.17 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "I", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Pat Warren Drain.
10. **THAT** The Treasurer shall levy the amount of \$71,925.78 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "J", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Jarvis 1 Drain.
11. **THAT** The Treasurer shall levy the amount of \$143.98 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "K", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the County Road 3 Drain.
12. **THAT** should the assessed owners of the lands elect to pay the amounts levied over a five (5) year period, such amounts shall be assessed, levied and collected in the same manner and at the same time as other taxes of the municipality are assessed, levied and collected, upon and from such parcels of land listed in the aforementioned Schedules "A" through "K", together with interest thereon at a rate that shall be established as 6.0% per annum except where the assessment against any parcel of land is five hundred dollars (\$500.00) or less, where such assessment shall be paid in four installments over one calendar year.
13. **AND THAT** this by-law shall come into force and take effect on the date of passing.

THE CORPORATION OF HALDIMAND COUNTY

By-law Number 1868/17

Being a by-law to levy the actual cost of maintenance of the Sweets Corners, King Branch 1 & 2, Sixth Concession, Weikman, Lundy, North Forks, South Forks, Maple Creek, Pat Warren, Jarvis 1 and County Road 3 Municipal Drains on the assessed lands

WHEREAS Section 61 of the *Drainage Act*, R.S.O. 1990, c.D17 provides that the council of the local municipality that is required to raise the cost of drainage works shall by by-law impose the costs upon the assessed land, payable in such installments as the council may prescribe;

WHEREAS Section 74 of the *Drainage Act*, R.S.O. 1990, c.D17 requires that the local municipality raise the cost of maintenance of drainage work at the expense of all upstream lands and roads in any way assessed for the construction or improvement of the drainage works;

WHEREAS the Sweets Corners Municipal Drain was maintained by Haldimand County at a total project cost of \$11,534.42 and now requires the remaining costs, after any applicable grants/allowances, of \$9,393.18 to be recovered from the lands benefiting from said work;

WHEREAS the King Branch 1 & 2 Municipal Drain was maintained by Haldimand County at a total project cost of \$26,737.05 and now requires the remaining costs, after any applicable grants/allowances, of \$21,364.82 to be recovered from the lands benefiting from said work;

WHEREAS the Sixth Concession Municipal Drain was maintained by Haldimand County at a total project cost of \$48,071.43 and now requires the remaining costs, after any applicable grants/allowances, of \$35,699.07 to be recovered from the lands benefiting from said work;

WHEREAS the Weikman Municipal Drain was maintained by Haldimand County at a total project cost of \$9,291.20 and now requires the remaining costs, after any applicable grants/allowances, of \$7,470.52 to be recovered from the lands benefiting from said work;

WHEREAS the Lundy Station Municipal Drain was maintained by Haldimand County at a total project cost of \$31,401.58 and now requires the remaining costs, after any applicable grants/allowances, of \$28,308.34 to be recovered from the lands benefiting from said work;

WHEREAS the North Forks Municipal Drain was maintained by Haldimand County at a total project cost of \$63,799.72 and now requires the remaining costs, after any applicable grants/allowances, of \$51,817.08 to be recovered from the lands benefiting from said work;

WHEREAS the South Forks Municipal Drain was maintained by Haldimand County at a total project cost of \$69,001.46 and now requires the remaining costs, after any applicable grants/allowances, of \$50,243.16 to be recovered from the lands benefiting from said work;

WHEREAS the Maple Creek Municipal Drain was maintained by Haldimand County at a total project cost of \$49,267.37 and now requires the remaining costs, after any applicable grants/allowances, of \$41,471.47 to be recovered from the lands benefiting from said work;

WHEREAS the Pat Warren Municipal Drain was maintained by Haldimand County at a total project cost of \$5,869.01 and now requires the remaining costs, after any applicable grants/allowances, of \$4,391.17 to be recovered from the lands benefiting from said work;

WHEREAS the Jarvis 1 Municipal Drain was maintained by Haldimand County at a total project cost of \$84,980.82 and now requires the remaining costs, after any applicable grants/allowances, of \$71,925.78 to be recovered from the lands benefiting from said work;

AND WHEREAS the County Road 3 Municipal Drain was maintained by Haldimand County at a total project cost of \$209.91 and now requires the remaining costs, after any applicable grants/allowances, of \$143.98 to be recovered from the lands benefiting from said work;

NOW THEREFORE, the Council of The Corporation of Haldimand County enacts as follows:

1. **THAT** The Treasurer shall levy the amount of \$9,393.18 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "A", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Sweets Corners Drain.
2. **THAT** The Treasurer shall levy the amount of \$21,364.82 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "B", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the King Branch 1 & 2 Drain.
3. **THAT** The Treasurer shall levy the amount of \$35,699.07 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "C", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Sixth Concession Drain.
4. **THAT** The Treasurer shall levy the amount of \$7,470.52 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "D", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Weikman Drain.
5. **THAT** The Treasurer shall levy the amount of \$28,308.34 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "E", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Lundy Drain.

6. **THAT** The Treasurer shall levy the amount of \$51,817.08 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "F", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the North Forks Drain.
7. **THAT** The Treasurer shall levy the amount of \$50,243.16 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "G", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the South Forks Drain.
8. **THAT** The Treasurer shall levy the amount of \$41,471.47 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "H", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Maple Creek Drain
9. **THAT** The Treasurer shall levy the amount of \$4,391.17 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "I", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Pat Warren Drain.
10. **THAT** The Treasurer shall levy the amount of \$71,925.78 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "J", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Jarvis 1 Drain.
11. **THAT** The Treasurer shall levy the amount of \$143.98 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "K", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the County Road 3 Drain.
12. **THAT** should the assessed owners of the lands elect to pay the amounts levied over a five (5) year period, such amounts shall be assessed, levied and collected in the same manner and at the same time as other taxes of the municipality are assessed, levied and collected, upon and from such parcels of land listed in the aforementioned Schedules "A" through "K", together with interest thereon at a rate that shall be established as 6.0% per annum except where the assessment against any parcel of land is five hundred dollars (\$500.00) or less, where such assessment shall be paid in four installments over one calendar year.
13. **AND THAT** this by-law shall come into force and take effect on the date of passing.
