In regards to the OPP reporting methods, Member Hewitt advised that there is still confusion in what the County is contracting with the OPP for and what is being received. He is also concerned with officer visibility, which is a Board priority.

Prior to Ms. Bonnie Stephens addressing the Board, the Chair noted that the cell conditions had been discussed at the September Police Services Board meeting. Ms. Stephens outlined her concerns regarding the condition of the cells during the Labour Day weekend in September. After hearing her concerns Staff Sergeant Paton confirmed that the OPP have taken proactive steps to ensure, whenever possible, that all cells are cleaned after each use. The cell conditions will be monitored on a regular basis.

7.1 Correspondence from the OPP Municipal Policing Bureau dated September 26, 2012 Re: 2012 Semi-Annual Contract Policing Costs – Ontario Provincial Police

Karen General advised that this is a semi-annual document used for actual costs versus what has been billed. She noted that as long as the minimum contracted hours are met the County is charged the full amount of the contracted hours, however there are some discrepancies in the documents calculations. She then explained how the operating expenses are calculated. Karen has met with Superintendant Skinner, Western Region and with Sergeant Tsitomeneas and Sergeant Hummel from the Municipal Policing Bureau to explain the County's concerns with the calculations. They will review the report and provide a response to these concerns.
