By-law Number 1914/18

Being a by-law to amend By-law No. 1441/14 respecting Development Charges on Lands within the Corporation of Haldimand County

WHEREAS Section 2(1) of the *Development Charges Act*, S.O. 1997, c.27, as amended, authorizes municipalities to pass a by-law for the imposition of development charges against land to pay for increased capital costs required because of increased needs for services arising from development of the area to which this by-law applies;

WHEREAS Haldimand County enacted By-law No. 1441/14, being a by-law to establish Development Charges on lands within Haldimand County on the 20th day of May, 2014;

AND WHEREAS it is deemed necessary to amend By-law 1441/14 by amending Schedule "B" – "Residential Development Charges by Service and Unit Type" and Schedule "C" – "Non-Residential Development Charges by Service and Per Square Foot of GFA".

NOW THEREFORE, the Council of The Corporation of Haldimand County enacts as follows:

- 1. **THAT** Schedule "B", identified as "Residential Development Charges by Service and Unit Type", and Schedule "C", identified as "Non-Residential Development Charges by Service and Per Square Foot of GFA", of By-law 1441/14 be repealed and replaced with Schedule "B" and Schedule "C" attached hereto.
- 2. **THAT** this by-law shall take precedence over any other by-law with which it is inconsistent.
- 3. **AND THAT** the effective date of the by-law shall be May 20th, 2018.

READ a first and second time this 30th day of April, 2018.

READ a third time and finally passed this 30th day of April, 2018.
