

ORDER

All Residents of Haldimand County

RE: 4(1) ORDER – EFFECTIVE IMMEDIATELY

Order section 4(1) under the *Emergency Management and Civil Protection Act (EMPCA)*, R.S.O. 1990, Chapter E.9, as amended 2006, an **ORDER** has been issued by Ken Hewitt, Mayor of Haldimand County to all residents of Haldimand County.

You are hereby ordered to take the following actions:

1. Notwithstanding the provisions of Sections 4.55, 4.61, 4.107 and 4.109 of the Town of Dunnville Zoning By-law 1-DU 80, Sections 4.105 and 4.10 of the Town of Haldimand Zoning By-law 1-H-86, and Section 2.111 of the City of Nanticoke Zoning By-law NE-1-2000, residents of Haldimand County who are self-isolating in accordance with directives of the Medical Officer of Health will immediately be permitted to occupy a motor home, park models or travel trailer in an existing and legally established, seasonal campground provided that the property owner allows it and that all other health and safety agency approvals for water and wastewater are in place. This order will expire concurrent with the removal of the State of Emergency.
2. Notwithstanding any provisions to the contrary in the Town of Dunnville Zoning By-law 1-DU 80 or in the Town of Haldimand Zoning By-law 1-H-86 or in City of Nanticoke Zoning By-law NE-1-2000, residents of Haldimand County who are self-isolating in accordance with directives of the Medical Officer of Health, will immediately be permitted to occupy an attached or detached secondary suite within any zone that provides for and on which there has been established a single family dwelling. Any such attached or detached secondary suite will be permitted within any required front yard. This order will expire concurrent with the removal of the State of Emergency.

3. For the proposes of this order a:

“SECONDARY SUITE” shall mean a self-contained living accommodation for an additional person or persons living together as a separate single housekeeping unit, in which both food preparation and sanitary facilities are provided for the exclusive use of the occupants of the suite, located within the principal dwelling on the lot or in an attached or detached accessory structure on the lot and shall include a motor home, park models or travel trailer provided that all other health and safety agency approvals for water and wastewater are in place and any applicable, if any, building permits are obtained.

THE REASON(S) for this ORDER is that:

1. Residents returning from travel, who reside in trailer parks and campgrounds are required to self-isolate.
2. All international travellers have been ordered by the province to return home and self-isolate

Therefore, based on the reason(s) noted above, I am of the opinion, on reasonable and probable grounds that:

1. Risk to the public is low risk

FAILURE to comply with an order made during a declared emergency is an offence for which you will be subject to a fine of \$750.00 under the EMPCA.
