5. Business Arising

5.1 GIS Mapping Presentation

Haleigh Buck, Senior GIS Technologist, and Megan Turner gave a follow-up demonstration of the a new mapping application that displays both designated and listed properties in various formats (sheet layers): Base map (aerial), topographic (geographic). Opportunities to include other fields, e.g. legal description, the date information was updated, etc. and photographs will be added. This application will also be used for storyboard mapping and include the location of each plaque.

5.2 Properties of Potential Heritage Significance

The Chair led further discussion related to the GIS presentation and noted some immediate changes to the PPHS listing could be made for example, four properties listed have been designated:

- 3355 River Road, Cayuga (Cook Peart House)
- 266 Irish Line, Cayuga (Murray Walton House)
- 5 Mohawk St E, Cayuga (Duff House and Log Cabin)
- 601 Haldimand Road 12, Fisherville (Charles Reichheld House)

And, ten properties listed at either vacant or new builds. These include:

- 6372 Highway 3. Canfield newer building
- 46 Munsee Street North, Cayuga newer build original house lost in fire

- 550 Townline Road, Cayuga vacant land
- 0 Townline Road East, Cayuga vacant land
- 85 Decewsville Road, Cayuga newer build
- 204 Alder Street West, Dunnville new house/garage 1990
- 664 Marshagan Road, Dunnville new build 2012
