- 5.1 Update Ongoing Projects
- 5.1.1 Hagersville Active Living Centre (HALC)

To date approximately \$1.5 million has been donated towards this project. Community fundraising is coming soon. This project has been added to the Capital Budget which was approved and ratified on March 7. From preliminary consultation Pickle Ball was identified as something that the Community would like to see in the building and the footprint has been slightly enlarged to include three(3) courts as opposed to two(2). Input for this project will be accepted over the course of the year and this project has a fundraising goal of \$2 million.

Spring Consultations are being scheduled for the HALC.

5.1.2 Community & Recreation Facilities Strategy

Survey closed with 2000 validated responses. In-person consultation scheduled for April 4<sup>th</sup> and 5<sup>th</sup> at four locations around the County.

Site visits have occurred to look at opportunities for new facilities and enhancements that can be made to existing locations.

Report on the findings from the Consultant will go to Council in June 2022.
