



SERVICE CONNECTION PERMIT APPLICATION

WATER, SANITARY ^{AND} / OR STORM

Application General Provisions:

- A no charge application must be completed and submitted (dropped off or via e-mail) to the Haldimand County Administration Building:
 - A submitted application is not permission to commence excavation.
 - One application is required for each individual or set (water and sewer) of services.
- To expedite the approval process, please include the following with the application:
 - A site plan showing property boundaries and proposed service location (include service size and material)
 - If working within the County right of way, confirmation that a road excavation permit has been obtained from the County's Roads Department.
- Applicants will be contacted by Water and Wastewater Operations staff within 3 business days of application receipt.
 - Upon notification of approval, permits can be paid for and picked up at the County Administration Building.
- Inspected service installations will be billed Flat Rate (water and sewer) on a monthly basis, according to the County's Water and Wastewater Charges By-Law, until a water meter is installed. The property owner must request a meter installation through Water and Wastewater Operations.
