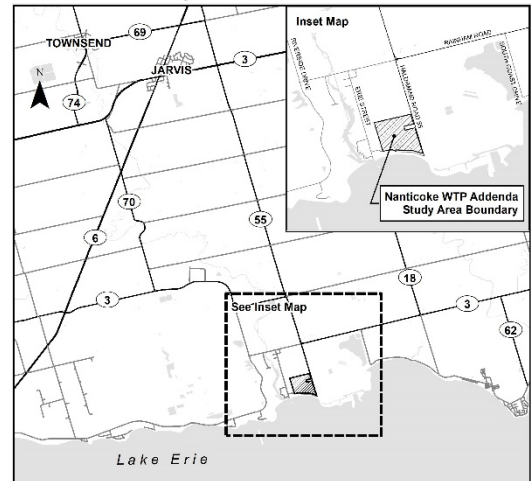

Haldimand County Nanticoke Water Treatment Plant Addendum to Extend the Environmental Study Report

THE STUDY

Haldimand County has initiated the process of filing an addendum to extend the existing Environmental Study Report at the Nanticoke Water Treatment Plant. In 2002, Haldimand County conducted a Municipal Class Environmental Assessment for the expansion of the Nanticoke Water Treatment Plant and filed the Environmental Study Report in 2006.

The preferred scenarios that resulted from this assessment were to expand the water treatment plant to accommodate growth within the current service area and to meet the needs of an expanded service area. The demand on the water treatment plant and the plans to extend the service area are being realized but the current Environmental Study Report is beyond the ten-year validity as set out in the Environmental Assessment Act.



THE PROCESS

The purpose of this Addendum to Extend the Environmental Study Report is to re-evaluate the findings of the 2006 Municipal Class Environmental Assessment (Class EA) under the current regulatory, social, and environmental landscapes to ensure that the findings are still valid. The alternatives proposed may have an impact on stakeholders and rightsholders and input will be sought throughout the study. As part of the Class EA, studies of the area's archeology, cultural heritage, and ecology will be undertaken. Stakeholders should note that a separate but related Notice of Study Commencement was issued by Norfolk County for the ["Simcoe-Townsend Water Supply System Municipal Class EA"](#) (opens in web browser). The Simcoe-Townsend study being completed by Norfolk will implement an approximately 20 km length transmission water main that connects Simcoe to the Townsend Water Supply System, to secure water supply from the Nanticoke Water Treatment Plant. Interested parties are referred to Norfolk's project webpage for a detailed description of that work. If comments pertain to both studies, please reach out to both study teams.
