### Message from the Administrator

Spring has finally arrived, bringing with it a sense of hope and renewal.

#### Welcome Cathy Fisher!

I am pleased to announce that Cathy Fisher has accepted the temporary Supervisor of Programs & Support position and joined the Grandview Lodge team on March 20<sup>th</sup>. As our new Supervisor of Programs & Support, Cathy will be responsible for leading the Recreation department in creating and implementing programs which promote physical, emotional, spiritual and mental well-being of our residents. Cathy brings a wealth of knowledge and expertise to our team, having previously worked in the long term care sector for the City of Hamilton and Region of Peel. Cathy's passion for enhancing the quality of life for residents in long term care is evident in her past and current work. Her creative ideas and commitment to excellence will help us enhance the recreational services we provide. Please join me in welcoming Cathy to our team.

#### New Screening Guidelines—No more Rapid Testing Required:

As we approach the end of the respiratory illness season, we believe that the risk of severe outcomes to residents has been reduced. The Ministry of Long Term Care has decided to adjust the current response measures to COVID-19. The following changes will come into effect on **April 1st**, **2023**:

- Asymptomatic rapid testing is no longer required for staff, students, volunteers, support workers, caregivers and visitors.
- Visitors and Caregivers will conduct passive screening; <u>Active screening has been</u> <u>removed</u>. You will see a new process set up on March 27<sup>th</sup> and our screeners will walk you through our new passive screening protocol. (Rapid testing is still required up till the 31<sup>st</sup>.)
- No limit on the number of essential caregivers during an outbreak or if a resident is under isolation.
- **Masks are still required during your visit**; however, you may take off your mask in a resident room during a visit, but prior to leaving that room you must place it back on.
- Staff are still required to wear a mask at all times.

The goal of Ontario's COVID-19 response is a *balanced approach* which aims to protect residents from severe outcomes of COVID-19, while minimizing the impact on resident's overall health and well-being through prevention, detection and management of COVID-19 in higher-risk settings. We still have a very important role to play in protecting our residents, staff and visitors. Please ensure upon entry you sanitize your hands, answer the passive screening questions and if you are not well, please reschedule your visit to a time when you are feeling better.

With the ending of active screening and rapid testing, our Screeners are no longer required. We would like to extend a heartfelt thank you to our screeners; Alice, Casey, Seth, Carol & China, for their unwavering commitment to the safety of our residents and staff over the course of the last few years. Your dedication and hard work were truly appreciated and we are grateful for all have you have done for the Grandview Lodge community. You will be missed!

As we wrap up this newsletter. We want to remind you that we are always here for you and your loved ones. If you have any questions or concerns, please don't hesitate to reach out to us. Thank you for your continued trust and confidence in our care team.

# Rate Reductions Timelines

It is that time of year again! You guessed it.... Income Tax Season and with that comes Rate Reductions.

This is a reminder of the timelines set out for Rate Reduction Applications.

Canada Revenue Agency has set the date to have your income taxes filed <u>no later than</u> <u>Sunday April 30, 2023</u>. This will give you enough time to receive your Notice of Assessment which is necessary to start the Rate Reduction Application Process.

In the month of May, we will require anyone who is receiving a rate reduction currently or has net income under \$25,050, as stated in on Line 23600 of the Notice of Assessment, to bring in a copy and sign the Rate Reduction application with Pam. The deadline for this date is May 31, 2023.

For those who are receiving GAIS/GAINS please provide us with a copy of the Resident's benefit as this will further reduce their income. Please see the memo below from the Ministry of Long-Term Care Home:

Under Ontario Regulation 246/22 (Regulation) of the Fixing Long-Term Care Act, 2021, the Ministry of Long-Term Care (ministry) offers a reduction in long-term care home accommodation rates for eligible long-stay residents residing in basic accommodation. The Long-Term Care (LTC) Rate Reduction Program mitigates the risk of financial hardship for residents who, despite having exhausted all available income, are unable to afford the current basic accommodation rate. Since the LTC Rate Reduction program is an incomebased program, a resident's rate reduction is calculated based on the resident's standardized income assessment as outlined in the Regulation. Under subsection 299(4) of the Ontario Regulation 246/22, any benefits, entitlements, supplements, settlements or other financial assistance that the resident receives pursuant to an Act of the Parliament of Canada, legislature of a province or territory, or any foreign government, that are directed for a specified purpose, and that the Director determines should not be considered in determining annual net income, shall not be considered in determining a resident's annual net income. The government is helping vulnerable seniors by doubling the Guaranteed Annual Income System (GAINS) payment for all recipients for 12 months starting in January 2023. Under the authority of subsection 299(4), this letter is to inform long-term care licensees that the increase as a result of the doubling of the 2023 GAINS payment amount, which GAINS recipients will begin receiving in January 2023, must not be considered in the determination of a resident's annual net income in the current or upcoming LTC Rate **Reduction Program Cycles.**

#### **Nursing**

Grandview's Nursing Team continues to flourish and build upon our core mission of comfort, compassion, and care to support our residents. April is **National Oral Health Month** and we want to share some great information for you and your loved ones. One of our core care programs includes assisting and encouraging all our residents with proper oral hygiene routines.

Did you know that oral health could affect more than just your mouth? It can affect your heart, brain, and ability to control diabetes. As we age our teeth undergo changes that can be affected by chronic diseases and the use of certain

medications. Caring for dentures and implants is as important as caring for the natural teeth. Redness or swelling of the gums is common among older adults wearing dentures that no longer fit well.

Research suggests that there appears to be a link between poor oral health and dementia but the exact nature of the relationship is still unknown. However, evidence shows that older adults living with dementia may:

- Have more cavities than older adults without dementia
- Have difficulty chewing their food
- Experience pain in the mouth they may not be able to communicate to others
- Have generally poor denture hygiene
- Have dry mouth




