  - 5.1.1 Community Museums Operating Grant (CMOG) The Supervisor, Heritage & Culture provided an update regarding the CMOG program and the requirements of the grant for 2023.
  - 5.1.2 Young Canada Works 2023

The Supervisor, Heritage & Culture provided an update related to Haldimand Museums three successful applications for this year. Wilson MacDonald and Edinburgh Square received funding for two summer positions – 12 weeks, Collections Assistants, to assist with collections projects and the sites and the third, an Intern (September to March, 2024) who will concentrate on the development of virtual programming. Funding for all three positions was awarded at 50% of total wages and benefits.

### 5.2 Haldimand Museums Strategic Planning The Manager, Community Development & Partnerships presented a high-level review of the first round of discussions with the Curators. Haldimand Museums are evolving and continuing to grow and the HMAB will play a role in the development of the plan.

5.3 Haldimand Museums Accessibility Plans
 The Board was provided with an opportunity to review the Accessibility Plans for the three
 Haldimand Museums' sites. These plans tie to the County's overall accessibility Plan and policy.
 Board members discussed the content of each plan and provided feedback to the Curators.
