

THE CORPORATION OF HALDIMAND COUNTY

By-law Number 2463/23

**Being a by-law to amend By-law 2385/22 – Stop Control
By-law (Caledonia, Cayuga, Jarvis and Hagersville
subdivisions; Springvale)**

WHEREAS Section 27 (1) of the *Municipal Act*, 2001, c. 25., as amended, authorizes a municipality to pass by-laws in respect of a highway under its jurisdiction;

WHEREAS Section 137 subsection (a) of the *Highway Traffic Act*, R.S.O. 1990., c.H.8, as amended authorizes a municipal council to pass by-laws providing for the erection of stop signs at intersections on highways under its jurisdiction;

AND WHEREAS the Council of the Corporation of Haldimand County deems it expedient to amend By-law 2385/22 with respect to stop conditions throughout Haldimand County,

NOW THEREFORE, the Council of The Corporation of Haldimand County enacts as follows:

1. **THAT** Schedule “A” Stop Location of By-law 2385/22 be amended by adding the following:
