### 3. Rural Water Quality Projects

S. Brocklebank from the Grand River Conservation Authority presented four Rural Water Quality Projects for the committee's approval.

File # Haldimand 94 – Cover Crop Proposal for 2 fields of cover crops, 7 acres and 30 acres.

Moved by D. Court, and seconded by H. Lise that the project be approved totaling \$520.00 at 6:03 pm. Carried.

File # Haldimand 124 – Tree Planting Proposal to plant a mix of 1300 native deciduous and coniferous trees.

Moved by C. Snyder, and seconded by D. Court that the project be approved totaling \$1,401.00 at 6:06 pm. Carried.

File # Haldimand 127 – Cover Crop

Proposal to plant 80 acres of cover crops of oats, radish and peas following wheat.

Moved by H. Lise, and seconded by S. Heeg that the project be approved totaling \$1500 at 6:07 pm. Carried.

File # Haldimand 128 – Well Decommissioning Proposal to decommission a 6" diameter, 25-30' deep well.
