By-law Number 2509/24

### Being a by-law to amend Schedule "O" of By-law 2459/23 User Fees and Services Charges By-law

**WHEREAS** Haldimand County enacted By-law 2459/23 in accordance with Section 391(1) of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, for the purpose of imposing fees or charges for services or activities provided, for costs payable for services or activities provided or done by or on behalf of the municipality and for use of its property including property under its control;

**AND WHEREAS** it is deemed expedient to amend By-law 2459/23 so as to revise fee schedule "O".

**NOW THEREFORE, the Council of The Corporation of Haldimand County enacts as follows:**

1. **THAT** By-law 2459/23 be amended by deleting Schedule "O" identified as By-law Enforcement/Animal Control, and replacing it with Schedule "O", as attached hereto and forming part of this by-law.
2. **THAT** this by-law shall be effective on the date of passing.
3. **AND THAT** this by-law shall take precedence over any by-law with which it is inconsistent.
